Introduction

What are prohibitions and restrictions?

The European Union acquis includes a significant number of legal provisions that mandate customs authorities and other relevant authorities to carry out controls at EU external borders. Such controls are key to enforcing and ensuring compliance with many different policies enshrined in Union law and contribute to the security and safety of the European Union and its citizens.

In accordance with Articles 134 and 267 of Union Customs Code¹ (UCC), prohibitions or restrictions may be imposed on imports, exports or goods in transit when they are justified on grounds of:

- public morality, public policy or public security,
- the protection of health and life of humans, animals or plants,
- the protection of the environment,
- the protection of national treasures possessing artistic, historic or archaeological value
- and the protection of industrial and commercial property,
- including controls on drug precursors, goods infringing certain intellectual property rights and cash.

Fishery conservation and management measures and commercial policy measures are not considered prohibitions and restrictions, although their implementation is an intrinsic dimension of customs supervision, as also established by Articles 134 and 267 UCC.

Prohibitions and restrictions may cover different requirements, such as:

- Total prohibitions or bans²;
- Required controls at the border by specialised competent authorities (health, food safety, etc.)³;
- Quantitative restrictions under a quantity management system⁴;
- An authorisation or registration of the importer⁵ or exporter⁶;

- An authorisation/approval by an authority, or a notification to an authority of the shipment;
- Additional documentation (licences, permits, certificates, etc.) accompanying the consignment⁷;
- Rules governing the placing on the market of products.

What is this document?

In collaboration with the other relevant Directorates-General of the European Commission, the Directorate-General for Taxation and Customs Union drew up this document to enhance public access to information about EU policies in general and prohibitions and restrictions in particular.

This document is a compilation of the existing prohibitions and restrictions at EU level. It should serve as a practical instrument for the European Institutions and the customs and other competent authorities of the Member States as well as other interested stakeholders. The intent is to keep this information timely and accurate and updates are expected to be published regularly.

This document is non-exhaustive and non-binding and is subject to the Legal notice (a.o. Disclaimer, Privacy policy and Copyright notice) and Brexit content disclaimer available on the Commission website. The Commission accepts no responsibility or liability whatsoever with regard to the information in this document.

Dates mentioned are the main dates of application, but there may be specific dates of application (e.g. in case specific articles enter into application earlier or later than the act in general) or transitory provisions. Please always check all details, and specifically the dates of application, in the latest consolidated version of the act.

What is included in this document?

The document contains references with hyperlinks to Union legal acts that entail prohibitions and restrictions at EU external borders. Some measures have direct implication for the customs authorities, while others are just provided for information as the decision to involve customs is a matter of national implementation.

Usually, this document includes only the main act and not delegated or implementing legislation. Where the main act is only a framework legislation and understanding its subject matter and scope requires a reference to delegated or implementing acts, the relevant secondary legislation is included. This applies, in particular, to the following sectors:

- Ecodesign;
- Ecolabel;
- Energy labelling;
- Official controls and
- General product safety.

- Sanitary and phytosanitary emergency measures⁹.

EU sanctions¹⁰ under Articles 29 TEU and 215 TFEU are excluded from this exercise.
